The Author hereby submits to Telegael Teoranta (hereinafter "Telegael") the conditions set forth in the pages that follow.

- The Author recognises the possibility that the submitted material may be similar or identical with material that has or may come to Telegael from other sources. Telegael will refuse to consider the Material unless it can obtain a full release of liability sufficiently broad to protect it, its related companies, its employees, agents, licensees and assigns, and all parties to whom it submits material. The Author understands that Telegael would refuse to receive or accept the Material in the absence of the acceptance by the Author of each and all of the provisions of this release. Therefore, as an inducement to Telegael to receive, accept and examine the Material, and in consideration of it so doing, as well as the mutual covenants herein contained, the Author hereby represents, warrant and agrees and Telegael hereby agrees as follows:
- The Material is voluntarily submitted and the Author is the present and sole owner of all right, title and interest in and to the Material with the exclusive unconditional right and authority to release the Material to Telegael upon the terms and conditions set forth herein. No third party is entitled to compensations as a condition of the use of the Material and the Author hereby agrees to indemnify and hold Telegael harmless from any and all claims, expenses, losses, or liabilities that may be asserted against or incurred by Telegael at any time in connection with the use of the material, including without limitation, those arising from any breach or alleged breach of the warranties and covenants given by the Author herein, including reasonable legal fees and other costs incurred defending against the same.

3. The Author acknowledges that Telegael receives numerous submissions of ideas, formats, stories, suggestions and screenplays, which submissions may be similar or identical to his submission and that the Author will not be entitled to any compensation because of the use by Telegael of any such similar or identical material.
4. Telegael agrees that it will not use the Material unless it shall first negotiate with the Author compensation for such use, but the Author agrees that the use by Telegael of materials containing features and elements similar to or identical with those contained in the Material shall not oblige Telegael to negotiate with the Author nor entitle the Author to any compensation if Telegael determines that it has an independent right to use such other materials containing features and elements which may be similar to or identical with those contained in the Material but which is not derived from the Author, either because such features and elements were new or novel or were not originated by the Author, or because other persons have submitted or may submit material containing similar or identical features of elements which Telegael has right to use.
5. The Author retains all rights to submit this Material or similar material to persons or entities other than Telegael. The Author has retained at least one copy of the Material and releases Telegael from any and all liability for loss or damage to copies of the Material herein submitted.
6. The Author acknowledges that no fiduciary or confidential relationship now exists between the Author and Telegael and that no such relationship is established by reason of this Release or by reason of the submission of the Material to Telegael.
7. In the event that the Material is selected for production by Telegael, both parties will execute a separate contract, which by its terms and provisions will be the only contract between the Author and Telegael stipulating the rights and obligations of each party and incorporating the Release reference. The Author hereby states that he has read and understands the Release; that no oral representations have been made to the Author; that there are no prior or contemporaneous agreements, oral or otherwise, in effect between the Author and Telegael pertaining to said screenplay or pertaining to the submission by the Author of any ideas, formats, plots, or characters; and, that this Release states our entire understanding. The Author expressly agrees that no other obligations exists or shall be deemed to exist unless and until a formal written agreement has been prepared and entered into by the Author and Telegael.
8. This Release shall be governed by the laws of the Republic of Ireland and subject to the exclusive jurisdiction of the Irish courts.
